


ICADE SANTÉ'S CSR COMMITMENTS IN THE 2021–2025 STRATEGIC PLAN AND 2021 RESULTS

Leading healthcare real estate company in France, aiming for a strong presence in Europe, Icade Santé has committed to a CSR strategy intended to meet key environmental and social challenges. Through its own business activities and its long-term partnerships with healthcare operators, Icade Santé seeks to reduce its environmental footprint, build resilience, promote impactful solutions as well as to improve the quality of patient care and experience.

In order to create the most value for its stakeholders through its CSR strategy, Icade Santé has integrated and analysed their expectations through a materiality matrix. Icade Santé's most recent materiality matrix identifies four priority issues directly correlated to its core activity:

- Climate: Commit to a low-carbon strategy to fight climate change and develop the performance and resilience of facilities.
- Accessibility of care: Contribute to increasing the care provided to meet local needs and users' expectations.
- Occupants' health and well-being: Take action for the comfort and well-being of patients, residents and staff;
 and ensure the suitability of premises to new medical practices.
- Skills development: Give all employees access to quality training, support new ways of working to encourage collaboration, cross functionality, innovation and employee commitment.



To tackle these priority issues, Icade Santé has set out CSR commitments based on three pillars: environmental, social and governance. Regularly monitored and reported on annually, these CSR commitments are an integral part of Icade Santé's 2021-2025 Strategic Plan.
